**FULL RELEASE OF ACT OF MULTIPLE INDEBTEDNESS MORTGAGE,
ASSIGNMENT OF AS-EXTRACTED COLLATERAL, SECURITY AGREEMENT,
Fixture Filing and Financing Statement**

BEFORE the undersigned Notary Public, duly commissioned and qualified in and for the County and State set forth on the signature page below, and in the presence of the undersigned, competent witnesses, on the date set forth on the signature page below, but to be effective as of the 21st day of January, 2026 (the “Effective Date”), personally came and appeared

SOCIETE GENERALE, as security agent (“Security Agent”), having a mailing address of 245 Park Avenue, New York, New York 10167, represented herein by and appearing through Eric Kim, its duly authorized Managing Director, which declared as follows:

Security Agent is the holder of record of that certain Act of Multiple Indebtedness Mortgage, Assignment of As-Extracted Collateral, Security Agreement, Fixture Filing and Financing Statement, executed by ShenHai, LLC, a Delaware limited liability company, and filed in the mortgage records of Iberia Parish, St. Mary Parish and Terrebonne Parish, Louisiana and with the Bureau of Ocean Energy Management (the “BOEM”) in the adjudication (non-required) files for leases (a) OCS-G 25232, WR 52, (b) OCS-G 28148, WR 53 and (c) OCS-G 31938, WR 51, as further described on Exhibit A attached hereto (the “Mortgage”).

The Mortgage was granted pursuant to Article 3298 of the Louisiana Civil Code to secure the then present and future obligations and indebtedness on an automatic basis without the necessity of individual mortgage notes paraped “Ne Varietur” for identification with the Mortgage.

The maximum amount of the obligations and indebtedness secured by the Mortgage was fixed at FIVE BILLION AND 00/100 DOLLARS (US \$5,000,000,000.00).

All of the obligations and indebtedness secured by the Mortgage having been fully paid and satisfied, Security Agent has agreed to the release of the Mortgage pursuant to Louisiana Civil Code Article 3366 and La. R.S. 9:5169.

Security Agent, for valuable cause and consideration received, the sufficiency of which is hereby acknowledged, does hereby fully and irrevocably release and grant a full discharge of the Mortgage and of any and all liens, assignments, and security interests purported to be granted by the Mortgage.

Security Agent does hereby authorize and direct (a) the Clerk of Court and Recorder of Mortgages (the “Clerk”) of each of Iberia Parish, St. Mary Parish and Terrebonne Parish, Louisiana to (i) record this Full Release of Act of Multiple Indebtedness Mortgage, Assignment of As-Extracted Collateral, Security Agreement, Fixture Filing and Financing Statement (this “Release”) in the mortgage records of such parish, (ii) release and cancel in full the Mortgage on its face in the mortgage records of such parish, and (iii) notate or make mention of this Release in the margin of the mortgage records of such parish where the Mortgage was recorded as stated in Exhibit A hereto, and (b) the BOEM to file this Release in the adjudication (non-required)

files for leases (i) OCS-G 25232, WR 52, (ii) OCS-G 28148, WR53 and (iii) OCS-G 31938, WR 51.

Security Agent hereby represents and warrants (a) that it is the mortgagee (“Mortgagee”) of the Mortgage and the current obligee of record of the obligations and indebtedness secured thereby and (b) that none of its rights as Mortgagee thereunder or as holder of the obligations and indebtedness secured thereby have been transferred or assigned.

Security Agent further agrees to hold harmless, indemnify and defend any person or entity for any damages resulting to such person or entity as a consequence of reliance on the above warranties or of the releases and cancellations of said Mortgage.

All capitalized terms used herein and not otherwise defined have the meanings given such terms in the Mortgage. Unless the context requires otherwise, any term that is used in this Release and is defined or explained in the Mortgage shall have the meaning ascribed to it in the Mortgage.

This Release shall be effective for all purposes as of the Effective Date, regardless of any date of execution or recordation.
