**JOINT WRITTEN CONSENT OF THE MEMBERS AND MANAGERS OF
SANDMAN OFFSHORE, LLC**

Effective: March 13, 2026

Pursuant to the Texas Business Organizations Code (“**TBOC**”), the undersigned members, being a Majority Interest of the members (“**Members**”) of Sandman Offshore, LLC, a Texas limited liability company (“**Company**”) and, the undersigned managers, being all of the Managers of the Company, hereby consent in writing to the adoption of the following resolutions and take the following actions, effective as of the date set forth above, which shall have the same force and effect as if adopted at a duly noticed and validly held meeting of the Members and the Managers. Capitalized terms used herein and not otherwise defined herein have the meanings given them in that certain Company Agreement of Sandman Offshore, LLC, dated as of January 4, 2023, as amended by the Assignment and Reallocation of Membership Interests, effective November 20, 2025 (the “**LLC Agreement**”).

1. Removal and Appointment of Managers

WHEREAS, pursuant to Section 5.3 of the LLC Agreement, the Members may remove a Manager by Majority Interest, and pursuant to Section 5.8(d) of the LLC Agreement, the Members may take such action without a meeting by written consent;

WHEREAS, the LLC Agreement was amended on November 20, 2025, and pursuant to such amendment, Robbins Energy Group, LLC (“**REG**”) was admitted as a member of the Company with a Sharing Ratio of 20%, and each other Member’s Sharing Ratio was reduced from 25% to 20%;

WHEREAS, a Majority Interest of the Members deem it advisable and in the best interests of the Company to remove Russell Hinds as a Manager of the Company and to appoint REG, acting by and through Robin Visceglia, as a Manager of the Company;

NOW THEREFORE, BE IT RESOLVED, that a Majority Interest of the Members hereby remove Russell Hinds as a Manager of the Company; and

FURTHER RESOLVED, that, in accordance with Sections 5.3 and Section 5.8 of the LLC Agreement, a Majority Interest of the Members hereby appoint REG, acting by and through Robin Visceglia, as a Manager of the Company, to serve until its successor shall have been duly elected and qualified, or until its prior resignation or removal.

2. Manager Authorizations

WHEREAS, the Managers may act on behalf of the Company in such capacities as provided for in the LLC Agreement, as may be amended from time to time, and in accordance with the TBOC;

WHEREAS, the Managers deem it advisable and in the best interests of the Company to expressly designate themselves as authorized parties to execute oil and gas lease bids, assignments, releases, easements, rights-of-way and other related instruments on behalf of the Company, in accordance with the provisions of the LLC Agreement; and

NOW THEREFORE, BE IT RESOLVED, that David Wegner and REG, in their capacity as Managers of the Company, are hereby designated as authorized parties to execute oil and gas lease bids, assignments, releases, easements, rights-of-way and other related instruments on behalf of the Company.

3. General Authority; Ratification of Prior Acts

RESOLVED, that any and all actions heretofore taken or caused to be taken by the Members or Managers of the Company consistent with the tenor and purport of the foregoing resolutions are hereby ratified, confirmed and approved in all respects by and on behalf of the Company; and






