Memorandum of Overriding Royalty Interest Agreement

STATE OF LOUISIANA §
PARISHES OF LAFOURCHE & TERREBONNE §

This Memorandum of Overriding Royalty Interest Agreement (the "*Agreement*") is effective as of December 1, 2022 (the "*Effective Date*") by and between Anadarko US Offshore LLC ("*Anadarko*"), a Delaware limited liability company whose address is 1201 Lake Robbins Drive, The Woodlands, Texas 77381, OGOG (Warrior) Inc. ("*OGOG*"), a Delaware corporation whose address is 251 Little Falls Drive, Wilmington, Delaware 19808, and Ridgewood Warrior, LLC ("*Ridgewood*"), a Delaware limited liability company whose address is 1254 Enclave Parkway, Suite 600, Houston, Texas 77077, each individually a "*Party*" and collectively the "*Parties*".

Recitals

Whereas, effective as of February 1, 2017, MCX Exploration (USA), LLC ("*MCX*") assigned a ten percent (10%) record title interest to Ecopetrol America Inc. (now Ecopetrol America LLC ("*Ecopetrol*")) and a five percent (5%) record title interest to Anadarko in OCS-G 34984, Green Canyon Block 519 (the "*GC 519 Assignment*") and reserved a five percent of eight-eighths (5% of 8/8ths) overriding royalty interest "reduced in proportion of the assigned interest";

Whereas, effective as of February 1, 2017, MCX assigned a ten percent (10%) record title interest to Ecopetrol America Inc. (now Ecopetrol America LLC) and a five percent (5%) record title interest to Anadarko in OCS-G 34992, Green Canyon Block 563 (the "*GC 563 Assignment*") and reserved a five percent of eight-eighths (5% of 8/8ths) overriding royalty interest "reduced in proportion of the assigned interest" (the overriding royalty interests reserved by MCX in the GC 519 Assignment and GC 563 Assignment are collectively referred to as the "*MCX Overrides*");

Whereas, effective December 1, 2022, Anadarko (forty percent (40%) record title), OGOG (thirty percent (30%) record title), and Ridgewood (thirty percent (30%) record title) jointly own all right, title, and interest in the leases and lands described in Exhibit "A-1" and depicted in Exhibit "A-2" (the "*Warrior Prospect Area*"), attached hereto and made a part hereof; and

Whereas, notwithstanding prior assignments, conveyances, or transfers, Anadarko, OGOG, and Ridgewood desire to bear the MCX Overrides, proportionately reduced to MCX's 15% record title interest when it reserved the MCX Overrides, in proportion to their respective record title interests as more particularly set forth below.

Agreement

Now, therefore, in consideration of the premises, the mutual promises herein contained, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Anadarko, OGOG, and Ridgewood hereby agree as follows:

1. **Overrides Borne Proportionately.** Each of the MCX Overrides, which are proportionately reduced to MCX's 15% record title interest when it reserved the MCX Overrides, as to the leases and lands described in Exhibit "A-1" and depicted in Exhibit "A-2", shall be borne in proportion to Anadarko's, OGOG's, and Ridgewood's respective record title interests as follows:

Anadarko	40%
OGOG	30%
Ridgewood	30%
TOTAL	100%

2. **Governing Agreements.** This Agreement is made subject to and governed by (each a "*Governing Agreement*"):

- (a) that certain Participation Agreement dated effective as of December 1, 2022, by and between Anadarko Petroleum Corporation, Anadarko US Offshore LLC, Ecopetrol America LLC, and OGOG (Warrior) Inc. covering the leases and lands described in Exhibit "A-1" and depicted in Exhibit "A-2";
- (b) that certain Participation Agreement dated effective as of December 1, 2022, by and between Anadarko Petroleum Corporation, Anadarko US Offshore LLC, Ecopetrol America LLC, and Ridgewood Warrior, LLC covering the leases and lands described in Exhibit "A-1" and depicted in Exhibit "A-2";
- (c) that certain Joint Operating Agreement dated effective as of August 1, 2013, by and between Anadarko Petroleum Corporation, Anadarko US Offshore LLC, et al. , as amended and ratified, covering the leases and lands described in Exhibit "A-1" and depicted in Exhibit "A-2";
- (d) the GC 519 Assignment; and
- (e) the GC 563 Assignment.

Except with respect to Paragraph 1 (*Overrides Borne Proportionately*), above, should any of the terms of this Agreement conflict with the terms of a Governing Agreement, the terms of the Governing Agreement shall control. There shall be no merger of said Governing Agreement with this Agreement.

3. **Term.** The term of this Agreement shall commence on the Effective Date and shall terminate:

- (a) as to Oil & Gas Lease OCS-G 34984 covering Green Canyon Block 519 (the "*GC 519 Lease*"), upon termination, relinquishment, or expiration of the GC 519 Lease; and

(b) as to Oil & Gas Lease OCS-G 34992 covering Green Canyon Block 563 (the "*GC 563 Lease*"), upon termination, relinquishment, or expiration of the GC 563 Lease.

4. Counterparts. This Agreement may be executed in one or more counterparts. Each counterpart shall be considered an original and all such counterparts hereof shall be construed together as one instrument. No party shall be bound by this Assignment until all parties have executed and delivered a counterpart.

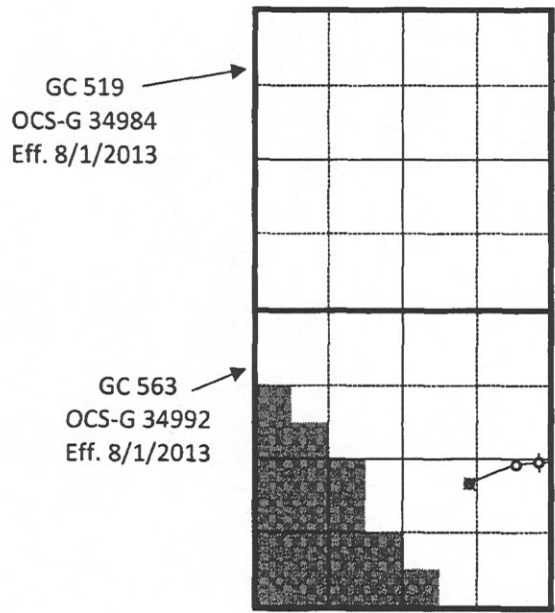
