Dear Mr. Schulte:

Your letter dated August 16, 2023, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SUR0032495, in the amount of \$695,000, was received by our office on August 18, 2023. This bond, conditioned to cover Right-of-Way OCS-G 1506, was executed on June 30, 2015, with Grand Isle Corridor, LP as principal and Argonaut Insurance Company as surety.

Attached to and forming a part of Bond No. SUR0032495, is Increase Bond Rider, executed on August 20, 2018, which increases the bond amount by \$339,768 for a total penal sum of \$1,034,768. The rider is effective March 28, 2018.

Bond No. 612418287 in the amount of \$1,034,768 has been accepted and covers the amount of this bond. Therefore, the Bureau of Ocean Energy Management has no objection to cancellation of Bond No. SUR0032495, which is considered cancelled without residual liability effective September 6, 2023, the date of final concurrence with the cancellation.

Grand Isle Corridor, LP ("Grand Isle") (GOM 3387) submitted the following bond, dated effective July 1, 2015, to the Bureau of Ocean Energy Management "BOEM" to cover OCS-G 1506;

1. Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond by Argonaut Insurance Company, as Surety and Grand Isle Corridor, LP, as Principal, bearing Bond No. SUR0032495 covering OCS-G 1506, in the amount of \$695,000.00, dated effective July 1, 2015, plus the bond rider dated effective March 28, 2018 increasing the bond amount to \$1,034,768.00, collectively hereinafter referred to as the "Original Bond".

Grand Isle requests cancellation of the Original Bond because it is assigning all of its interest in the referenced right of way (OCS-G 1506) to Crescent GIGS, LLC ("Crescent") (GOM 3673).

Crescent has acquired and filed under separate cover letter, the following New Replacement Bond.

2. Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond by United States Fire Insurance Company, as Surety and Crescent GIGS, LLC, as Principal, bearing Bond No. 612418287, in the amount of \$1,034,768.00 dated May 11, 2023, effective May 31, 2023, hereinafter referred to as the "New Replacement Bond". This bond replaces and supersedes the Original Bond.

Since the New Replacement Bond covers "All Obligations of all previous Sureties or guarantors even if the Obligations are not Obligations of the Principal during the period of liability of this bond" Grand Isle requests that the above referenced Original Bond be fully released and canceled.
