Dear Mr. Kolenda:

Your letter dated January 31, 2024, requesting termination of the period of liability and cancellation of Outer Continental Shelf Right-of-Way Grant Bond No. 103172911529, in the amount of \$300,000, was received by our office on February 1, 2024. This bond, conditioned to cover the principal's pipeline operations in the Gulf of Mexico, was executed on August 2, 2001, with Endymion Oil Pipeline Company, LLC as principal and Travelers Casualty and Surety Company of America as surety.

Attached to and forming a part of Bond No. 103172911529, is a Name Change Bond Rider, executed on February 12, 2002, which changes the name of the principal from Endymion Oil Pipeline Company, LLC to Mardi Gras Endymion Oil Pipeline Company, LLC. The rider is effective February 12, 2002.

Pursuant to 30 CFR 556.906 (d)(1) your bond may be cancelled seven years after the termination of the lease, six years after completion of all bonded obligations, or at the conclusion of any appeals or litigation related to your bonded obligation, whichever is the latest. This Criteria has been met.

The Bureau of Ocean Energy Management has no objection to cancellation of the above bond. Therefore, Bond No. 103172911529 is considered cancelled without residual liability, effective February 15, 2024, the date of final concurrence with such cancellation.

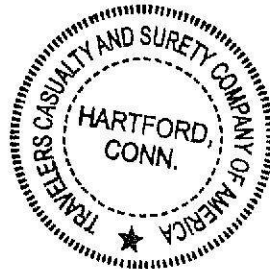
