Your letter requesting cancellation of Outer Continental Shelf (OCS) Pipeline Right-of-Way Grant Bond No. 103486479, in the amount of \$300,000, was received by our office on June 18, 2025. This bond, conditioned to cover the principal's pipeline operations in the Gulf of America, was executed on January 19, 2001, with Duke Energy Field Services, LP as principal and Travelers Casualty and Surety Company of America as surety.

Attached to and forming a part of Bond No. 103486479, is Name Change Bond Rider, executed on December 6, 2006, which changes the name of the principal from Duke Energy Field Services, LP to DCP Midstream, LP. The rider is effective January 1, 2007.

Attached to and forming a part of Bond No. 103486479, is Name Change Bond Rider, executed on January 20, 2017, which changes the name of the principal from DCP Midstream, LP to DCP Operating Company, LP. The rider is effective January 4, 2017.

The Bureau of Ocean Energy Management has no objection to cancellation of the above bond. Therefore, Bond No. 103486479 is considered cancelled without residual liability, effective June 18, 2025, the date of final concurrence with such cancellation.
