Dear Ms. Kelly:

Your letter dated June 25, 2025, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's and Operator's Bond No. 103758695, in the amount of \$300,000, was received by our office on that same date. This bond, conditioned to cover the principal's pipeline operations in the Gulf of America, was executed on April 17, 2003, with Newfield Exploration Company as principal and Travelers Casualty and Surety Company of America as surety.

Pursuant to 30 CFR 556.906 (d)(1) your bond may be cancelled seven years after the termination of the lease, six years after completion of all bonded obligations, or at the conclusion of any appeals or litigation related to your bonded obligation, whichever is the latest. The period of liability of Bond 103758695 was terminated September 14, 2016.

The Bureau of Ocean Energy Management has no objection to cancellation of the above bond. Therefore, Bond No. 103758695 is considered cancelled without residual liability, effective June 27, 2025, the date of final concurrence with such cancellation.

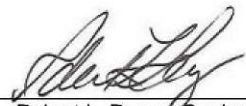

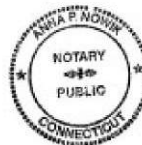

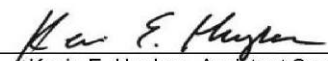
