Your letter dated December 5, 2025, submitting Decrease Bond Rider, to be attached to and form a part of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. SBP150014\_034, in the amount of \$2,145,000, was received by our office on that same date. This bond, conditioned to cover Lease OCS-G 27051, all of Block 339, East Cameron Area, South Addition, was executed on November 21, 2022, with Talos ERT LLC as principal and Pennsylvania Insurance Company as surety.

Attached to and forming a part of Bond No. SBP150014\_034, is Decrease Bond Rider, executed on October 16, 2025, which decreases the bond amount by \$716,888 for a total penal amount of \$1,428,112. The rider is effective October 16, 2025.


