Your letter dated November 3, 2025, requesting cancellation of Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Supplemental Bond No. B005971, in the amount of \$29,211,000, was received by our office on November 13, 2025. This bond, conditioned to cover Lease OCS-G 5884, all of Block 52, Green Canyon, was executed on August 13, 2010, with MC Offshore Petroleum, LLC as principal and U.S. Specialty Insurance Company as surety.

Attached to and forming a part of Bond No. B005971, is Bond Rider No. 1, executed on August 23, 2012, which decreases the bond amount by \$6,362,813 for a total penal sum of \$22,892,187. The rider is effective August 23, 2012.

Attached to and forming a part of Bond No. B005971, is Bond Rider No. 2, executed on November 19, 2015, which increases the bond amount by \$1,162,682 for a total penalty sum of \$24,054,849. The rider is effective November 19, 2015.

The Bureau of Ocean Energy Management has no objection to cancellation of Bond No. B005971, which is considered cancelled without residual liability effective November 19, 2015, the date of final concurrence with the cancellation.
