Dear Ms. Kelly:

Your letter dated February 19, 2026, requesting termination and cancellation of Outer Continental Shelf Right-of-Way Grant Bond No. 5958792, in the amount of \$300,000, was received by our office on February 20, 2026. This bond, conditioned to cover the principal's pipeline operations in the Gulf of America, was executed on December 21, 1998, with Dynegy Midstream Services, Limited Partnership as principal and Safeco Insurance Company of America as surety.

Attached to and forming a part of Bond No. 5958792, is Name Change Bond Rider, executed on February 2, 2006, which changes the name of the principal from Dynegy Midstream Services, Limited Partnership to Targa Midstream Services, Limited Partnership. The rider is effective November 8, 2005.

Attached to and forming a part of Bond No. 5958792, is Name Change Bond Rider, executed on May 3, 2017, which changes the name of the principal from Targa Midstream Services, Limited Partnership to Targa Midstream Services LLC. The rider is effective July 28, 2011.

We are unable to grant this request due to an objection from the Risk Management Operations Section (RMOS) for one or more Right-of-Ways that still have decommissioning liability assessed.
