Your letter dated March 30, 2026, submitting replacement Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. SPA150014_033, in the amount of \$3,000,000, was received by our office on that same date. This bond, conditioned to cover the principal's leasehold interest held now or hereafter in the Gulf of America, was executed on May 15, 2026, with Fieldwood SD Offshore LLC as principal and SiriusPoint America Insurance Company as surety.

This bond replaces Outer Continental Shelf (OCS) Mineral Lessee's or Operator's Bond No. SBP150014_044, in the amount of \$3,000,000. This bond, conditioned to cover principal's leasehold interest held now or hereafter in the Gulf of Mexico, was executed on May 15, 2024, with Fieldwood SD Offshore LLC as principal, and Pennsylvania Insurance Company as surety.

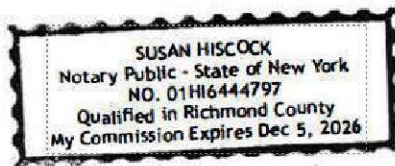

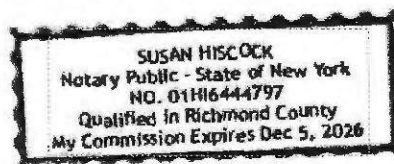

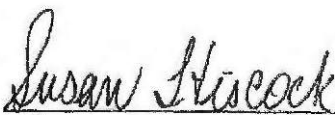
